PARENTAL CONSENT FORM

Dear Parent:

As you know, your son or daughter is in the process of applying for membership with the **Citizens Fire and Rescue Company #2** of Mechanicsburg, PA. Because your child is between the ages of 14 and 18 years old, the Fire Company seeks your permission to accept your son or daughter. Children that are ages 14 and 15 are considered at a **Junior Firefighter**. Children ages 16 and 17 are considered **Members with Restrictions** and will fill out a regular Member Application. In accordance with Pennsylvania's Child Labor Law, the status of **Junior Firefighter** places limitations on the activities that your child may become involved with. The following list highlights those activities that a **Junior Firefighter** **MAY NOT** participate in:

- May **NOT** operate an aerial ladder, a platform, or a hydraulic jack.
- May **NOT** use acetylene cutting torches.
- May **NOT** operate the pumps of any fire vehicle at the scene of a fire.
- May **NOT** drive an official fire vehicle.
- May **NOT** enter a burning structure.

Please be assured that the **Citizens Fire and Rescue Company #2** places firefighter safety as the top priority during all emergency response and training activities. Your son or daughter's personal safety will be monitored by other, more experienced company personnel during all activities.
